**Position: TRCCS/TRVCS Garden Educator**

**Duties:** Seeking an enthusiastic individual to be a Garden Educator for the Tomorrow River Community Charter School (TRCCS) and the Tomorrow River Virtual Charter School (TRVCS) who are working out of the principles of Public Waldorf Education. The candidate will develop, guide and implement curriculum to the needs of the individual child, while embracing the unity of the class as a whole, creating a nurturing learning environment for students in Grades PK-8. This individual will research, develop, and maintain a well-organized, useful and productive garden, greenhouse, composting program and chicken flock. He/she will work with the food staff and faculty on planning for food production and preservation for use in school lunches and within the classrooms. The Garden Educator will be responsible for weekly classes with the TRCCS students and organizing activities and onsite visits with TRVCS students, organizing parent volunteers, and planting, watering, weeding and harvesting.

**Qualifications:**

1. Hold a valid Wisconsin Teaching License or Teaching experience desired
2. Experience/training/certification in Waldorf Education/Biodynamic Agriculture desired
3. Able to physically perform all duties and have effective communication skills
4. A love for gardening, working with children, working with colleagues in a collaborative and supportive manner and openness for the unexpected.
5. Such alternatives to the above that the district may find acceptable

**Wage/Schedule:** The position is for 500 hours for the 2018/19 school year, with a potential of grant funding for additional hours; these hours are flexible with the seasonal needs of the garden. As an artist in residence, the pay would be \$18.82 an hour or equivalent FTE salary depending on experience with teaching license.
